1. OUR POLICY

4. RESPONSIBILITIES

General Manager	•	The General manager has the ultimate responsibility for this policy and must ensure, so far as is reasonably practicable, that the requirements of this policy are upheld, and that adequate resourcing is made available to address the requirements of this policy.	
Privacy Officer	•	The Privacy Officer is the conduit between Cruisemaster's clients, customers, and management. The Privacy Officer is Cruisemaster's key contact for members of the public and clients with privacy concerns. The Privacy Officer function is an additional task appointed to the customer service role.	
HSE Manager & Quality Manager	•	The HSE Manager and Quality Manager are responsible for reviewing this policy and associated procedures and processes through internal audit and management review.	
All managers and employees	•	All managers and employees are responsible for ensuring all clientele personal information is recorded, stored, and only used in accordance with this policy.	

5. PRIVACY PROCEDURES

5.1 Information Collected and/or Received

In the course of operating the website, and/or interacting with you, Cruisemaster will collect (and/or receive) the following types of information.

5.1.1 Contact Information

When you contact us through the 'Contact Us' feature on the website, make a product or service inquiry, order a product, make a product complaint or a warranty enquiry, or sign up to receive our newsletter or be on our mailing list, you will be asked to provide certain contact information. The contact information is used to provide the requested service or information and to contact you for purposes of direct marketing of our current and future services.

5.1.2 Order Information

When you order products through our website, we will ask you to provide certain additional information, including but not limited to, the products you would like to order, and the shipping information.

5.1.3 Billing Information

In order to purchase products, you will be required to provide certain billing information. Such billing information will be collected and processed by our third-party payment processor pursuant to the terms and conditions of their privacy policies and terms of use. Cruisemaster does not directly obtain, store, or process any billing information.

5.1.4 Other Information

In addition to the contact, billing, and order information, we may collect or receive the following information:

5.1.4.1 From Your Activity

In an ongoing effort to improve the website, we automatically collect certain information when you visit the website. This information consists of IP addresses, browser type and language, referring and exit pages,

URLs, date and time, amount of time spent on particular pages, what sections of the website you visit, and similar information concerning your use of the website (collectively, 'activity information').

5.1.4.2 From Cookies

We also collect activity information by using 'cookie' technology. Cookies are small packets of data that a website stores on the hard drive of your computer or mobile device to remember information about your visit. We may use session cookies (which expire once you close your web browser) and persistent cookies (which stay on your computer/device until you delete them). If you do not want us to place a cookie on your hard drive, you may be able to turn that feature off on your computer or mobile device. Please consult your internet browser's documentation for information on how to do this and how to delete persistent cookies. However, if you decide not to accept cookies from us, the website may not function properly.

5.1.4.3 Third-Party Analytics

We may use one or more third–party analytics services to evaluate your use of the website, compile reports on activity (based on their collection of IP addresses, Internet service provider, browser type, operating system and language, referring and exit pages and URLs, data and time, amount of time spent on particular pages, what sections of the website you visit, number of links clicked while on the website, search terms and other similar usage data), and analyse performance metrics. These third parties use cookies and other technologies to help analyse and provide us the data. By accessing and using the website, you consent to the processing of data about you by these analytics providers in the manner and for the purposes set out in this Privacy Policy. 5.2 Usage and Sharing of your Information

You authorise us to use the contact information, order information, and other information (collectively, the 'information') to provide our website and products to you, solicit your feedback, inform you about our products and services and those of our third-party marketing partners, and to improve the website. Also, we may use and share the information as described below.

5.3 Agents, Providers and Related Third Parties

We may engage other companies and individuals to perform certain business-related functions on our behalf. Examples may include providing technical assistance, order fulfillment, customer service, repair, installation or maintenance services, market research, billing and debt collecting services, insurance services, and marketing assistance. These other companies will have access to the information only as necessary to perform their functions and to the extent permitted by law. We may also share your information with any of our parent companies, subsidiaries, or other companies under common control with us.

5.4 Aggregated Information

In an ongoing effort to better understand users of the website, we may analyse the information in aggregate form in order to operate, maintain, manage, and improve the website. This aggregate information does not identify you personally. We may use this aggregate information for marketing purposes. We may share this aggregate information with our affiliates, agents, business and business partners, and other third parties. We may also disclose aggregated user statistics in order to describe the website and our products to current and prospective business partners and to other third parties for other lawful purposes.

5.6 Protection of your Information

Cruisemaster takes commercially reasonable security measures to protect your information from loss, misuse, and unauthorised access, disclosure, alteration, and destruction, considering the risks involved in processing and the nature of such data, and in compliance with applicable laws and regulations. You should keep in mind that no internet transmission is 100% secure or error-free. In particular, e-mail sent to or from the website may not be secure, and you should therefore take special care in deciding what information you send to us via e-mail or other electronic means.

5.7 Links to Third-Party websites

The website may, from time to time, contain links to other external websites. Please be aware that your information, including your personal information, may be transferred to, processed, maintained, and used on computers, servers, and systems located outside of your state, province, country, or other governmental jurisdiction where the privacy laws may not be as protective as those in your jurisdiction. If you are located outside Australia and choose to use website, you do so at your own risk.

5.9 California Privacy Rights
